## President's Report

2005 has been another year of commitment and growth for Netball Australia. The continued and strengthened support of our Member Organisations through their Boards, staff and volunteers has meant a number of joint initiatives have been undertaken and completed.

During the year we have seen the completion of the High Performance Review and development of a new High Performance Pathway, so necessary for the future development and sustained standards of our game.

The development and rollout of the Junior Netball Policy, which has been a collaborative venture with our MOs, has been completed and we are extremely proud of this excellent product. With the valued assistance of Netball Victoria the National Member Protection policy is also nearing completion with only minor changes to be addressed.

As part of its ongoing governance review, the Netball Australia Board recognised that the Memorandum and Articles of Association were in need of updating, and a process was undertaken with our Member Organisations to address this issue. The final document will be presented to the Council for acceptance at the Annual General Meeting on 29th April 2006.

All major policies of the organisation have been revisited and are being revised where necessary, to ensure the organisation is contemporary and current in its approach to managing netball into the future. The By Laws of the Association are under revision and will continue to be systematically reviewed and developed.

As the sport grows and develops corporate governance remains a specific focus of the Board. The Board has introduced a Board performance and Board education and Governance programs to ensure our ability to focus strategically. I am delighted to report that the Netball Australia Board also achieved much in the area of strengthening our corporate governance, including the development of a set of Netball Australia Governance Principles, the introduction of a Board Nomination and Remuneration Committee and the Netball Australia Board Code of Conduct, the development of an Executive Delegation policy for the Board and CEO and the completion of a Board skills audit and gap analysis.

In 2005 we sought to increase and improve our communications with our Member Organisations. In addition to the many meetings held across all levels of National and State/Territory program areas, we have introduced meetings with our State and Territory Presidents as a forum for networking amongst the State and Territory leaders of our organisation.

Netball's expanding brief saw the Directors move on the proposal to adopt a new corporate logo and style replacing the long standing previous logo. The launch of the new Netball Australia corporate identity represents more than just a change of logo for the organisation. The new identity assists in repositioning us as a progressive, contemporary and dynamic organisation and reinforces the community's recognition of netball as one of Australia's premier sports.

Now is the time for us to look outside the square for opportunities to grow our sport so that we can compete successfully in the market place for the sponsorship dollars and the media coverage we require for both our national competition and our national teams. We have to be increasingly aware of the professional requirements demanded by our corporate supporters and the media to advance netball on the national and international stage. It is important to be ahead of the game so that we are able to fulfil our plan of being able to properly support our athletes and put more dollars into the development of all areas of our sport.

In moving forward at a national level, we must also apply the same skills and dedication in supporting our Member Organisations to help them sustain and increase their grassroots membership. Innovations such as our community development programs and web-based communication programs are positive measures of this commitment.

On the international arena we have been leaders for many years in facilitating netball development programs and initiatives, particularly in the Asian region, where we are a member of the Asian Netball Federation. 2005 was no different in that Australia continued to donate time and expertise to our sister nations, to help them develop their domestic programs in competing internationally.

Our key partner in government, the Australian Sports Commission, has been a powerful and supportive ally in assisting us to strengthen our organisational and governance capacities and I wish to acknowledge Mark Peters and Peter Bartels in particular for their assistance and encouragement.

I would also like to acknowledge the continued support of the Australian Institute of Sport and its Director Dr. Peter Fricker, for their contributions to netball through the Netball Australia/ AIS 21 and Under Netball program.

Our National Team continues to be the public face of elite netball and will compete in the Melbourne 2006 Commonwealth Games to defend its gold medal

status. Liz Ellis became our most capped Australian netballer during this year. This record is a testament to her steely, determined approach and pride in representing her country.

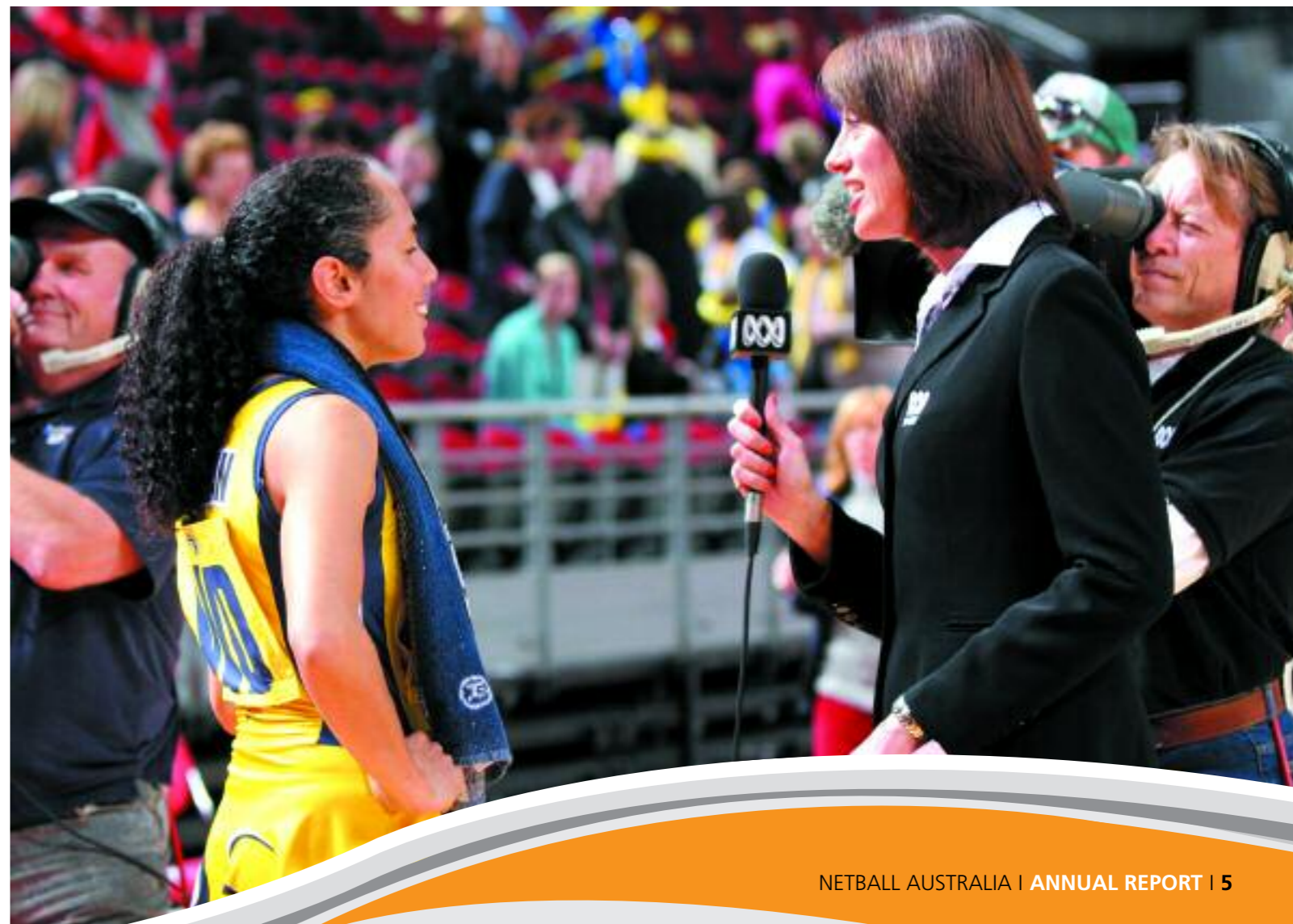
Netball Australia has annually supported the National Championship competitions for the Open and 21, 19, 17 and Under age groups where more than 350 athletes compete, seeking selection and talent identification. This year saw the final Open Championships contested in Canberra hosted by Netball ACT. To many of us it was sad to see this integral part of our history come to an end. However, as the Commonwealth Bank Trophy, our national league competition, is now firmly entrenched as a significant pathway to Australian representation, the Member Organisations deemed it time for the Open Championships, as we know them, to be replaced.

Volunteerism is a much appreciated role within our sport. However, our grass roots associations and Member Organisations are increasingly under pressure to maintain their volunteers. Attracting and retaining volunteers to our sport will be one of the greatest challenges facing the growth of netball in the coming years. I would like to take this opportunity to thank all those volunteers who each week make this the most popular and well organised female sport in the country for hundreds of thousands of participants.

I would also like to thank the NA Council and the Member Organisations for their continued commitment to the NA Board to achieve our national goals and strategies.

My sincere thanks to our CEO, Lindsay Cane and her dedicated staff team for their efforts on behalf of the organisation. To the individual members of my Board, thank you for your expertise, time and passion as we commit our sport to continued success through strategic, organisational and financial development. One thing remains a constant in our sport - that our members and volunteers will continue to enjoy the opportunity to engage in our unique and wonderful sport.

## CEO's Report

### 2005- A very big year

The year 2005 has been both challenging and exciting for Netball Australia. It was a year in which we moved forward on some very pivotal organisational and business developments such as the national membership system, our high performance review and Commonwealth Bank Trophy review. It was a year in which our Australian netball program was tested on the world stage in the World Youth Netball Championships in Fort Lauderdale, Florida. It was also an important year of preparations for the Open National team and all those people supporting the team, as we planned our representation at the Commonwealth Games in Melbourne 2006.

The following pages of this Annual Report report on the progress made by Netball Australia over the course of the past 12 months and how the organisation and its people went about our role of managing and promoting the game on behalf of the Australian netball membership in 2005. These pages also talk about the work done on behalf of netballers across the country to deliver our national programs successfully to our members, while re-structuring the organisation to position Netball Australia for future growth and even better service delivery.

### Responding to Members

In 2005 we responded to feedback from our members that indicated that we needed to improve our effectiveness in addressing the needs of our membership. We accepted this feedback enthusiastically, and set about developing and implementing: new standards of customer service from the national office staff; new levels of consultation and collaboration with our State and Territory Member Organisations; heightened activity in the area of advocacy and representation to governments and key decision-makers; a revised organisational structure that provided for more immediate and informed decision-making closer to the "coal-face"; introduced new operational and business systems that improved our efficiency in service delivery and improved the transparency of our processes to our members. We also conducted a critical review of how we allocate resources to various areas of the sport and our business, in an endeavour to make savings where possible and to generate new revenue streams and new opportunities for development.

### Achievements

As a consequence of this work and the endeavours of many people, both staff and volunteer, the organisation was successful on a number of fronts. Some of our achievements for the year included:

- Building a coordinated, national membership database resource for clubs and associations nationwide

- Preparing the National Open team for the Melbourne 2006 Commonwealth Games
- Attracting two experienced community netball people to join the staff team in two exciting new roles of Community Services Manager and IT and Member Services Manager
- Increased Australian Sports Commission funding for sport development and high performance
- Strengthening our communications with our elite player group and the Australian Netball Players Association
- Publication and distribution of the National Junior Netball Policy
- Launch of the dynamic new Netball Australia website
- Completion of the High Performance review and revision of the High Performance program
- Strengthening our relations with the national SIS/SAS network
- Recognition of the 1963 Australian Netball Team in the Australian Sports Hall of Fame
- Introduction of a new national Merchandise and Licensing Strategy
- A special visit to the remote Northern Territory indigenous community of Maningrida to deliver netball clinics
- Expansion of Commonwealth Bank Trophy games to regional areas, to support members in non capital cities
- Revision and updating of Netball Australia's Constitution and By Laws to ensure the organisation remains current and relevant to the Australian community
- Live broadcasts of the three international test series involving South Africa, England and New Zealand, with more than one million viewers tuning in to the Australia vs New Zealand test matches on ABC TV

### Challenges

On the fronts where we fell short of our goals we experienced some major organisational learnings. We adjusted business plans to accommodate these learnings and use them to strengthen our future performance. Some of the challenges we encountered and responded to throughout the year included:

- Losing our crown as World Youth Netball Champions to New Zealand
- Significant interruptions to the preparation of the national squad for Commonwealth Games due to unprecedented injuries, illness and pregnancies throughout the year
- An unexpected challenge by the Australian Workers Union on behalf of the Australian Netball Players Association, and subsequent industrial relations negotiations with the Australian Workers Union and Australian Netball Players Association

- The resignation of the National 21 and Under Coach following the 2005 World Youth Netball Championships and subsequent adjustments to the program for 2006
- A highly competitive sport sponsorship market, which meant that we fell short on our expectations in terms of financial support from corporate supporters

### Recognition

We are appreciative of the recognition netball receives from the Media, wider community and the Australian Sports Commission for being a sport of immense cultural significance as well as our obvious sporting significance to hundreds of thousands of participants, supporters and admirers. Netball remains strong in Australia as a premier grassroots sport. One ongoing challenge, which is being made slowly easier by the growing corporate support we are receiving, is to secure netball as a premier entertainment sport at the top end, which is supported by the media and commercial enterprise. Young women in Australia deserve to be given and be able to emulate positive, powerful role models. Australian netballers are shining examples of those positive role models, and deserve to be championed by our organisation as well as the community, to inspire and support women in their development.

### Partners

The Australian Sports Commission (ASC) is a key partner in Netball Australia, supporting our sport particularly well and enthusiastically at the elite level, as well as enhancing our community development programs. Netball Australia Directors, staff and volunteers appreciate the expert assistance and guidance that is provided by the ASC staff in the various technical areas, to assist us in our service delivery. I extend my thanks in particular to Mark Peters, Brent Espeland, Rob Clements, Phil Borgeaud, Peter Sharpe, John Armstrong, Mike McGovern and Wanda Sipa for their continued support of netball and our programs.

I would also like to thank the Director of the ASC, Dr Peter Fricker for his enduring guidance and support to the Australian Institute of Sport netball program, and all the technical specialists at the AIS who provide research data, analysis and the latest sports science to help us in our quest to be the best netballing nation in the world.

Our other important elite program partner, the Australian Commonwealth Games Association makes a significant contribution to the preparation of our elite national teams through the donation of financial resources to our two national teams. In particular, I would like to thank Perry Crosswhite and Sam Coffa for their ongoing support.

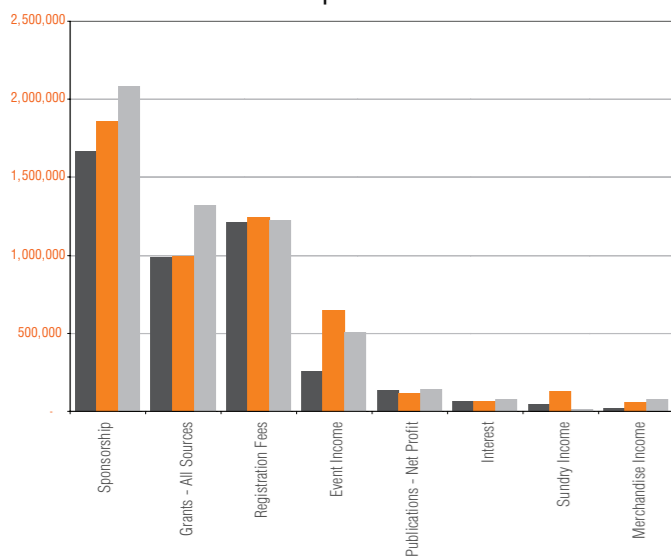
Netball Australia's corporate partners program was again strengthened in 2005 with the public announcement of Bendon and Holden as major supporters of the 2005 Australian program.

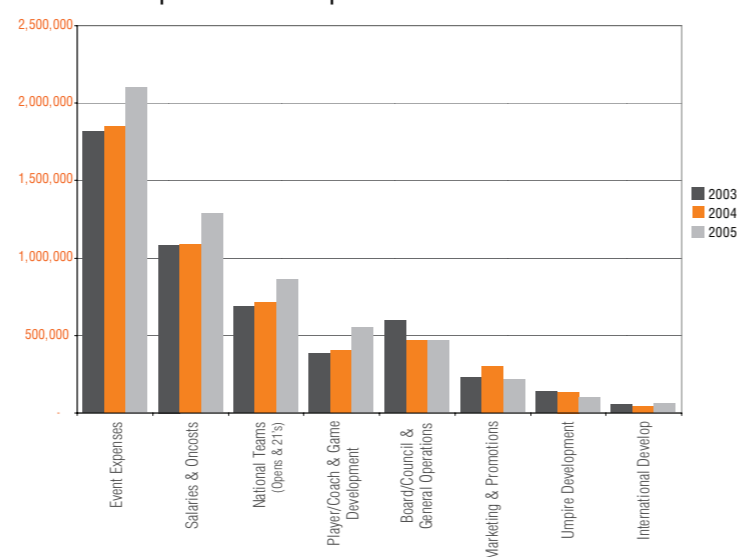




Revenue Comparison 2003-2005

The ABC TV team continued their excellent support of netball throughout 2005, and in 2006 we will be bringing an exciting new style of broadcast to the netball community.

Netball Australia enjoys the support of many other corporate friends who supply services, product and support, all of whom are recognised individually in the sponsorship section of this report.

Despite our battles on court with our Trans-Tasman rivals, we worked co-operatively off-court with Netball New Zealand throughout the year to confirm a 2006-2008 program of international test events. This program will provide netball members and supporters many chances to see our national "heroes" on court in Australia while also bringing benefits to the game in terms of goodwill, exposure and corporate support.

Netball Australia worked with other sports throughout the year to identify opportunities to collaborate on joint ventures where possible, and to take advantage of the collective wisdom and experience of those sports. In particular we enjoyed working on projects with Cricket Australia and AFL, while also having regular exchanges with Rugby, Swimming, Football, Hockey, Basketball and Cycling.

## Stakeholders and Supporters

Netball Australia recognise that the success of our sport, both nationally and internationally, is attributable to the many people and organisations that support our work and work closely with us in developing and delivering netball programs and services. I would like to acknowledge the great work that all groups do in being a part of the most significant women's sport in Australia.

In particular I would like to acknowledge the contribution of the players, coaches, administrators and officials at every level of our sport, who turn out every week to make their own significant contribution to netball in Australia.

## 2006 and Beyond

Looking forward, Netball Australia will be focused on our key strategic directions and objectives for 2006-2008, which include:

- Strengthening our international competitiveness and influence
- Increasing the profile and influence of Netball in Australia
- Creating new and sustainable competitions and events
- Recruiting new and retaining current members
- Growing the corporate investment into the sport
- Expanding our viewer and spectator base
- Increasing development opportunities for talented young athletes
- Working together on nationally agreed projects and programs
- Making continuous improvements to our governance, leadership and operational capacities
- Being aware of the needs of the membership and addressing these needs proactively
- Building efficient and effective organisational systems and business processes

## Finance and Business Operations

In 2005 Netball Australia continued the organisational development, program review and implementation of new initiatives that we began in 2004. This work required significant investment in the human resources of the organisation, both in the form of new senior management and program staff members and an increased level of investment in our elite athletes and their national programs. Additionally, Netball Australia took on the responsibility of funding the development and implementation of the new national database and membership system, which required a major capital investment in 2005.

The membership increase in capitation fees to Netball Australia, agreed to in 2005, will take effect in 2006.

Vigilant and effective cost control measures were put in place throughout the year, together with an ambitious

sponsorship revenue program. Total revenue in 2005 increased by 6% over 2004, which was pleasing, and was reflected in higher levels of sponsorship support (12%), increased federal government funding through the Australian Sports Commission and additional merchandise and publications sales. Unfortunately, revenue from event income decreased, mainly reflected by poor attendances at the South African test match series, and membership registration income which was slightly reduced on the previous year.

Expenses for Board/Council and administration were maintained at the same level as the previous year. Staff resourcing rose by a planned 18% as we implemented an organisational structure that accommodated a senior management team, which we had not had previously, a new IT and Database Manager to manage the membership system and a new Community Netball Manager to replace the position previously held by Megan Simpson. These two new positions reflect the increased focus and investment by Netball Australia into community netball, in support of and in response to the members' needs at local, regional and State and Territory level.

Regrettably, the total level of sponsorship we had planned to achieve fell short of our ambitious target, resulting in a full year deficit of \$194K. The Australian team along with the Netta program each failed to attract a major sponsor in 2005, which was disappointing.

Throughout the year, Netball Australia responded to calls from members to change some of our business practices to support the Member Organisations better. In response to these calls, Netball Australia agreed to hand over to Member Organisation's the right to manage and retain the income and rights to Commonwealth Bank Trophy team naming rights sponsorships and a shared revenue arrangement with the host member organisation for the Commonwealth Bank Trophy final series beginning in 2006. The Commonwealth Bank Trophy team grants were discontinued to those teams who had secured naming rights sponsors in 2005.

More than \$1.5million was expended on flights, meals and accommodation for Commonwealth Bank Trophy athletes, national team members on tour and at camps and for Member Organisation, Board and Council meetings, business meetings, advocacy, Member Organisation visits and stakeholder meetings. Netball Australia continues to investigate better arrangements on travel and accommodation to reduce costs in these

areas. A very significant expenditure was made in 2005 into the 21 and Under national team in the year of the World Youth Netball Championships. Funding for other high performance initiatives increased by 38% over 2004.

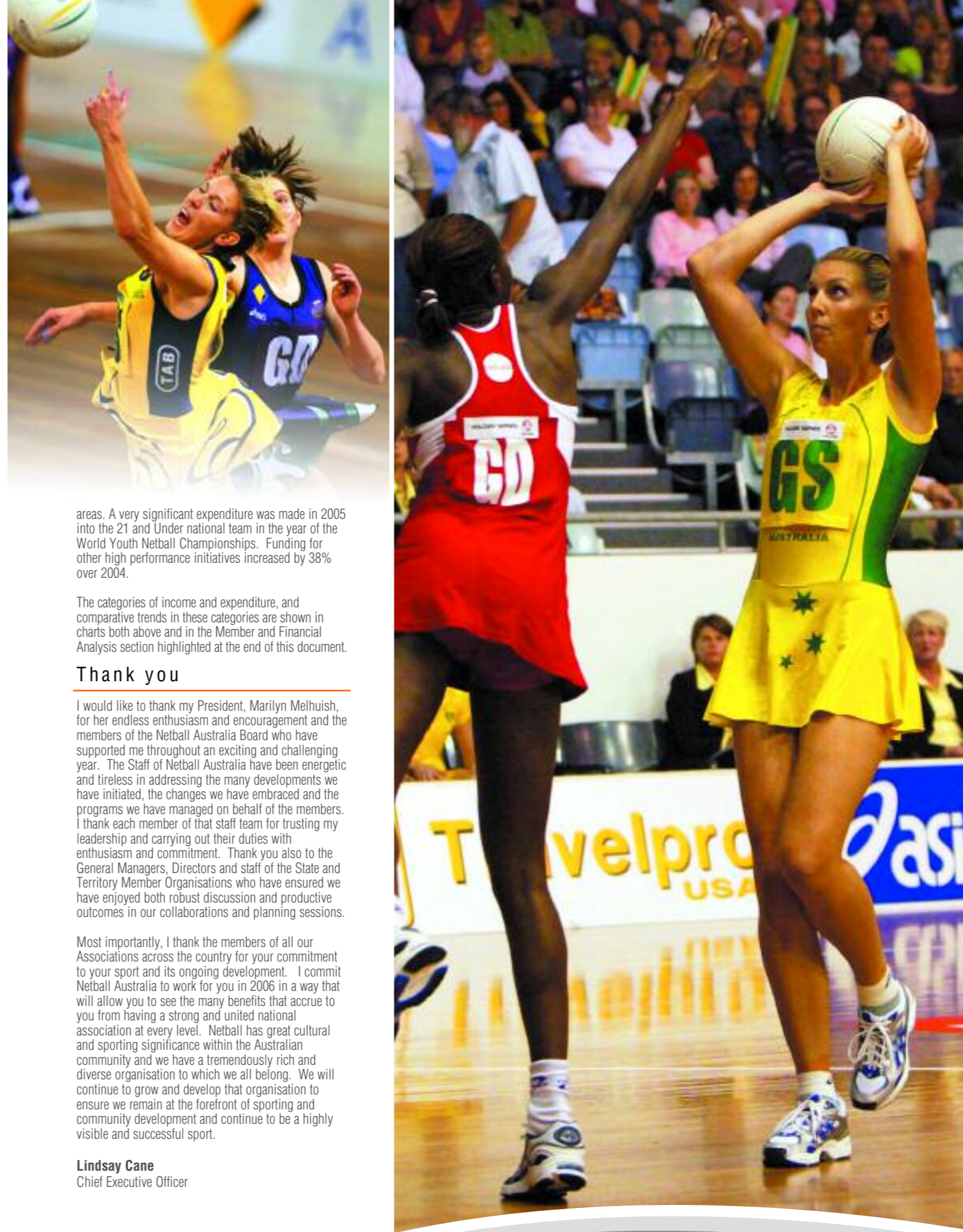

Netball has great cultural and sporting significance within the Australian community and we have a tremendously rich and diverse organisation to which we all belong. We will continue to grow and develop that organisation to ensure we remain at the forefront of sporting and community development and continue to be a highly visible and successful sport.

# Organisation

## Organisation

The All Australian Netball Association Limited (AANA) is a not-for-profit company limited by guarantee that operates under the business name of Netball Australia. Netball Australia is the national member association, comprising its eight State and Territory members and all members associated with these associations.

Netball Australia administers the game of netball using a wide range of resources. In addition to the executive functions of the Chief Executive and the Board, Netball Australia's core business is split between four key departments as follows:

## Operations

Game Development, High Performance, Events and Competition Management, Umpiring, Community Development, National Database and Administration System, Membership, Information Technology, Australian Netball Players Association, Member Issues.

## Marketing, Communications and Commercial

National Marketing, Advertising, Merchandise and Licensing, Sponsorship, Business Development, Media Relations, Strategic Communications, Corporate Relationship Management, Publications Production, Publicity, Corporate Hospitality, Market Research, Promotions, Uniforms, Brand Management.

## Finance and Administration

Financial Management, Office Management, Resource Allocation and Purchase, Travel and Logistics Management, Purchasing, Compliance Management, Insurance.

## Executive

Corporate Governance, Leadership, Strategic Direction, Board Performance, Audit and Risk, Government Relations, Stakeholder Relations, Advocacy, Resource Allocation

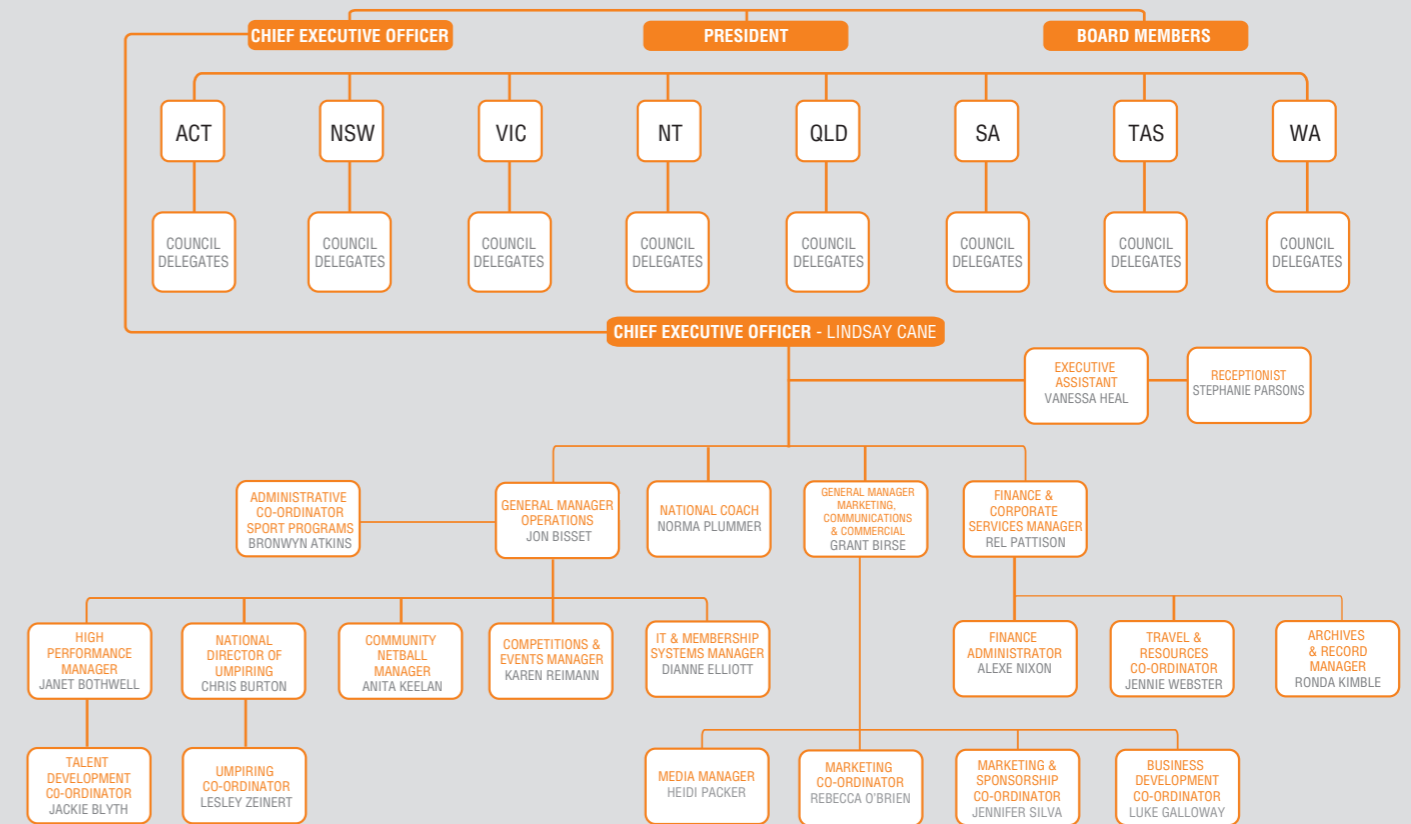
## Board of Directors

Directors on the Board serve a two-year term and are eligible to re-nominate for election at the end of that period. The Board comprises eight non-executive directors and one executive director (Chief Executive Officer). The full Board of Netball Australia meets a minimum of seven times per year. In 2005 the Board recorded 100% attendance.

Council Delegates from each State and Territory member organisation (or MO), plus the Netball Australia Board met twice during 2005 to receive reports on Netball Australia activities from the Board of Directors and to address specific issues reserved for the Council under the Constitution.

The Board of Netball Australia continues its commitment to strong governance, sound decision-making and responsible and strategic national leadership.

## Community Development and Membership

### Objectives

- To increase community participation, membership recruitment and member retention
- To deliver high quality service and support to members

### Strategy 05 – 08

At the very core of our business and our sport is the netball association and club membership. Netball is owned and supported and underpinned by an extraordinarily large and skilled family of volunteers and members who provide loyal and expert support and service to their clubs and associations.

Local and State and Territory Member Organisations and Associations look to the national body for leadership, strategic direction, support, education and resources and as such, Netball Australia develops appropriate resources and services to support member needs and advance their interests.

In 2005 Netball Australia committed to continue to critically appraise and improve core benefits, services and value to our members. One example of this is the National Database and Administration System that is set to revolutionise communication and information distribution between the membership.

With a small decline in national membership occurring in 2005, Netball Australia will continue to work closely with its State and Territory Member Organisations to ensure that the benefits provided to members as part of their membership are made tangible and apparent to all members.

In 2005 the State and Territory Member Organisations expressed confidence in, and indeed, a mandate to Netball Australia to invest more fully in community netball and membership programs, by accepting an increase in capitation fees to the national body. In response, Netball Australia committed to work closely with our members to provide greater support and resource to community netball and the development of national member services and support.

### Key Achievements

Netball Australia continued its commitment to regular communication and interaction with State and Territory Member Organisations. In 2005 regular meetings were held between the Member Organisation General Managers, the Coaches of the Commonwealth Bank Trophy Teams, the Coach Education and Player Development Group, the Umpire Development Committee, the Marketing Managers Group the Commonwealth Bank Trophy Event Managers Group, the Member Organisation Presidents and the Council of Netball Australia.

Unfortunately in 2005 there was 2.8% reduction in the number of nationally registered players and officials, with 327,846. Whilst the decrease was disappointing, membership numbers in the last 10 years have remained relatively stable. Netball maintained its ranking as the sport with the 4th largest number of participants in organised activities, with 509,900, in the Australian Sports Commissions Participation in Exercise Recreation and Sport Annual Report.

The quality and availability of the basic infrastructure which is required for safe and equitable participation, particularly in rural areas, continues to be a significant issue, as the current infrastructure will not support a significant increase in netball participation.

During the year Netball Australia certified 855 new coaches under Netball Australia's Coach Accreditation Program. At the heart of this program is Netball Australia's involvement in the National Coaching Accreditation Scheme (NCAS) of the Australian Sports Commission. A comprehensive review of netball programs under the NCAS was conducted in 2005 resulting in the development of a new coach education framework. A full roll-out will occur in all States and Territories in 2007. To support the National Coaching Program Netball Australia provided a total of \$72,000 in funding support to Member Organisations.

In 2005 Umpires continued to be integral to positive netball experiences for players, coaches and spectators at all levels of sport. A total of 739 new umpire badges were awarded by Netball Australia and Member Organisations during 2005, with over 85% being the C-Badge level.

During the year Netball Australia reinforced its commitment to the provision of safe, healthy and fun environments in which young people can participate in netball through the adoption of a Junior Netball Policy. The policy was developed in collaboration

with the eight State and Territory Netball Member Organisations, together with experts representing coaches, teachers, parents and netball administrators. The Policy is underpinned by a series of resources to assist local associations, clubs and schools with a means of quickly referencing key issues and strategies to assist in their implementation of the policy.

Netball Australia conducted a review into indigenous netball programs in 2005. The recommendations from the review will be considered in the development of a National Indigenous Strategy in 2006. Netball Australia provided funding totalling \$25,000 to support Western Australia's, Queensland's and the Northern Territory's indigenous programs in 2005.

Although growing the participation base of netball is a key priority for Netball Australia, the development of the Nextball program that commenced in 2004 was scaled back because the target market of Nextball fell outside core business of the organisation. A small pilot program is being conducted within 13 Action Indoor Sports Centres in Victoria which will enable Netball Australia to accurately test and evaluate the product within the market place before determining the future of the program.

### Future Direction

2006 will see an increase in Netball Australia's focus on the development of Community Netball. The priorities for 2006 include:

- Finalisation of the new Coach Education Framework and implementation throughout Australia.
- Development of DVD's, CD-Roms and coaching resources that reflect the new Coach Education Framework.
- Development of a Netball Action Plan for people with a disability.
- Implementation of Junior Netball Policy throughout all Associations and Clubs.
- Implementation of the National Member Protection Policy.
- Development of a National Indigenous Action Plan.
- Development of a Nationwide Facility and Venue Strategy for netball.
- Supporting Member Organisations to focus on the key areas for growth in Community Netball - Club Development, Facility Development, Coach Education and Junior Programs.





## High Performance

**Objective – To develop an effective high performance program that delivers success in International competitions including the Melbourne 2006 Commonwealth Games, World Championships 2007, World Youth Netball Championships 09**

### Strategy 06 – 08

During the year Netball Australia highlighted its role in the sport by conducting a review and evaluation of Netball Australia's range of High Performance Programs. The review was conducted with the assistance of the Australian Sports Commission through its High Performance Advisory Panel Program.

The review identified that the key to sustained International success will be the development of a program that provides a pathway for the most talented athletes to achieve their potential and maintain their long-term involvement in the international competition arena.

The primary outcome of the review was the development of Netball Australia's High Performance Plan that will create a new high performance culture and a sustainable system for the organisation.

The review resulted in the formulation of new player and coach pathways integrating the AIS and SIS/SAS network with underpinning talent development programs and national team structures.

In particular over the next few years Netball Australia will be taking a more proactive approach to talent development that will progressively improve the quality of junior athletes entering the national pathway as well as increasing the focus on elite coach development.

### Key Achievements

2005 was an important stepping-stone towards the Melbourne 2006 Commonwealth Games. The international competition program was expanded with Australian Senior team matches against South Africa, England, New Zealand and Jamaica. This strong international program coupled with a national camps program provided our national team with a good springboard from which to launch their Commonwealth Games assault.

In 2005 the Australian 21/U Team program focused on the World Youth Netball Championships that was held in the United States in July. A tour to the USA and Jamaica was held in February to provide essential match practice for our future stars. Details of the team and their results are provided later in this report.

In 2005 Netball Australia provided a total of \$80,000 funding to the State and Territory Institutes and Academies of Sport to provide the daily training environment to 16-19 year old athletes and a further allocation of \$36,000 for State and Territory associations to assist with their 17/U and 19/U elite programs. A camp for 17 and Under and 19 and Under talent identified athletes was held in Canberra in July. This investment will be significantly increased in 2006.

2005 also saw the introduction of an emerging squad of athletes to support the National Open/21 & Under programs and increase the depth within the playing ranks.

Through the support of the Australian Sports Commission \$360,000 was provided in Direct Athlete Support to the Australian Squad to assist the athletes with their preparation for the 2006 Commonwealth Games. This support was critical to allow athletes to maintain focused preparation, some of whom left their jobs to prepare in full.

Karen Worland was awarded a National Coaching Scholarship through the Australian Institute of Sport and was subsequently based at the Institute in 2005.

2005 was an extremely busy year for the National Umpiring program. Internationally Australia's umpires continued to be recognised as some of the best in the World with the following being selected by IFNA to officiate in International Matches:

During the year Netball Australia and global employment agency Adecco partnered in an exciting new initiative supporting Netball Australia players with workplace career development and employment opportunities. The Adecco Athlete Career Program supports Netball Australia players' integration into the workplace both during and after their sporting career, while complementing their sporting objectives.

### Future Direction

A number of key projects have been initiated as a result of the High Performance Review in 2005. During 2006 and 2007 Netball Australia will:

- Introduce National Junior Development Teams (19 and 17 & Under) that will participate in an annual exchange with our close international neighbours.
- Introduce a National SIS/SAS Camp to be conducted annually at the AIS to provide increased opportunities for our 16-19 year old athletes.
- Increase its focus on the development, particularly the mentoring of targeted future elite coaches.
- Engage a PhD student to undertake doctorate research, as well as the position of Performance Analyst responsible for the coding and analysis of national team matches and the integration of a national co-ordinated performance analysis program.
- Employment of a National Talent Development Coordinator to manage national talent development programs.





## Australian Team



### INTERNATIONAL TESTS

2005 was another busy year for the Australian Netball Team with series against England, South Africa, New Zealand and Jamaica. This extensive schedule is crucial in the lead up to the Melbourne 2006 Commonwealth Games.

The Australian Netball Team got the year off to a convincing start with an emphatic win over England in Melbourne. The South African's presented the second challenge of the year and Australia took a clean sweep over the visitors with victories in Perth, Adelaide and Melbourne.

Australia's great rivals the Silver Ferns were the next to arrive on Australian soil and the New Zealanders proved too good for the Australians in June with a seven point victory. Mo'onia Gerrard suffered a season-ending knee injury in this hard fought battle between the two best netball teams in the world.

The return match against the Silver Ferns in Auckland saw New Zealand defeat Australia 61 to 36. Liz Ellis suffered a knee injury early in this match and that injury would see her miss both the Jamaican Tour and selection in the Melbourne 2006 Commonwealth Games Squad.

Following its disappointing tour to New Zealand the Australian Netball Team set off to rebuild with a three Test Series against Jamaica which they won in a convincing clean sweep.

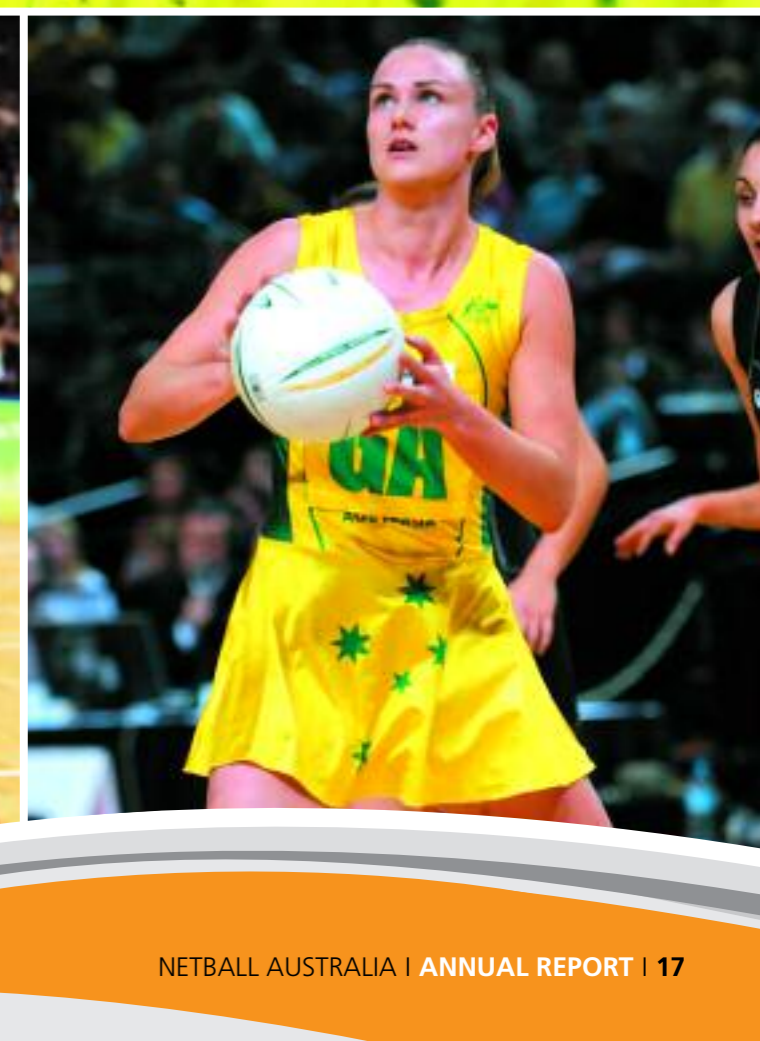
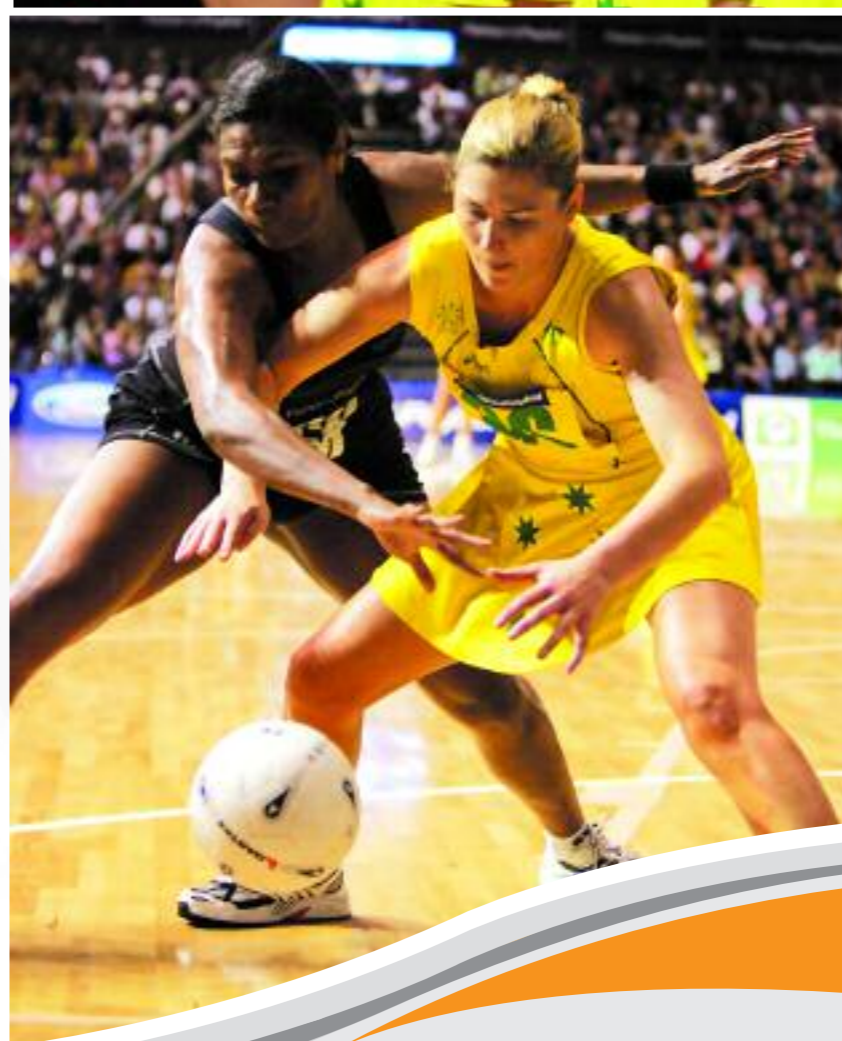

#### 2005 Open Championships

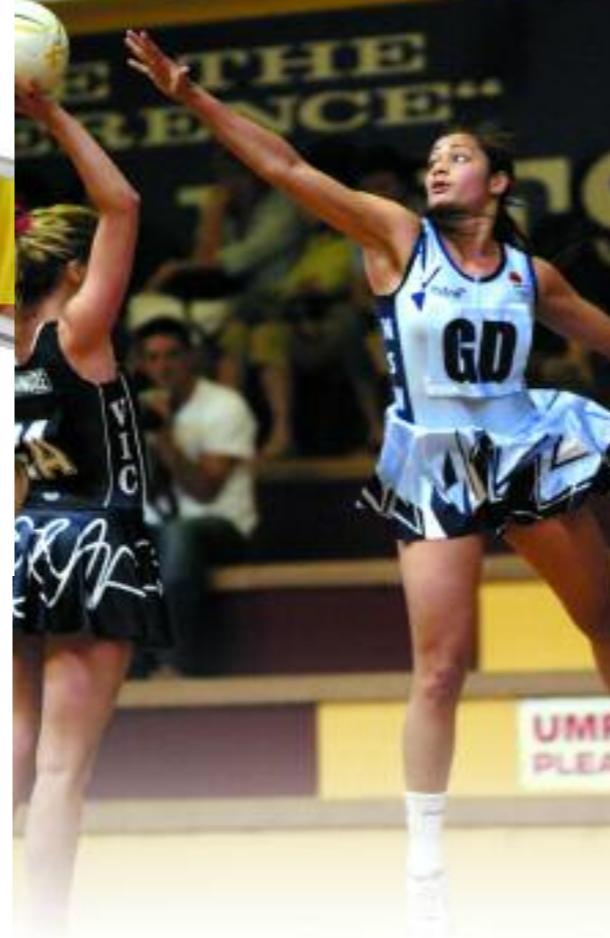

## Competition and Events

**Objective – To increase the strength and profile of Netball Australia's elite events**

### Strategy 06 - 08

The Commonwealth Bank Trophy will continue to be the flagship domestic competition for Netball Australia over the next few years. Netball Australia will be focusing on maximising the Commonwealth Bank Trophy competitions quality and sustainability while seeking to extend the entertainment value of the competition.

Netball Australia has promoted the economic viability and growth of the Commonwealth Bank Trophy by centrally exploiting additional revenue streams. Netball Australia's newly developed merchandise and licensing strategy will deliver both financial and 'visibility' benefits back to the Commonwealth Bank Trophy Competition through an increased brand presence in the consumer retail marketplace. It is critical that licensed product reflects the core brand and its values and becomes the tangible manifestation of the Netball Australia brand.

### Key Achievements

The ninth season of the Commonwealth Bank Trophy was conducted in 2005 with attendance figures increasing by 5.3% on 2004. The Grand Final attracted 6,258 fans, the second highest attendance at a Commonwealth Bank Trophy Grand Final since the competitions inception in 1997. Netball Australia assisted member organisations with the operational aspects of their teams participation in the league by providing a total of \$420,000 direct funding.

During the year there was an emphasis placed on greater exposure of the Commonwealth Bank Trophy season and elite netball throughout regional Australia. Matches were played in regional centres again in 2005 with games played in Darwin (NT), Townsville (Qld), Geelong (Vic), Wollongong (NSW) and Eaton (WA).

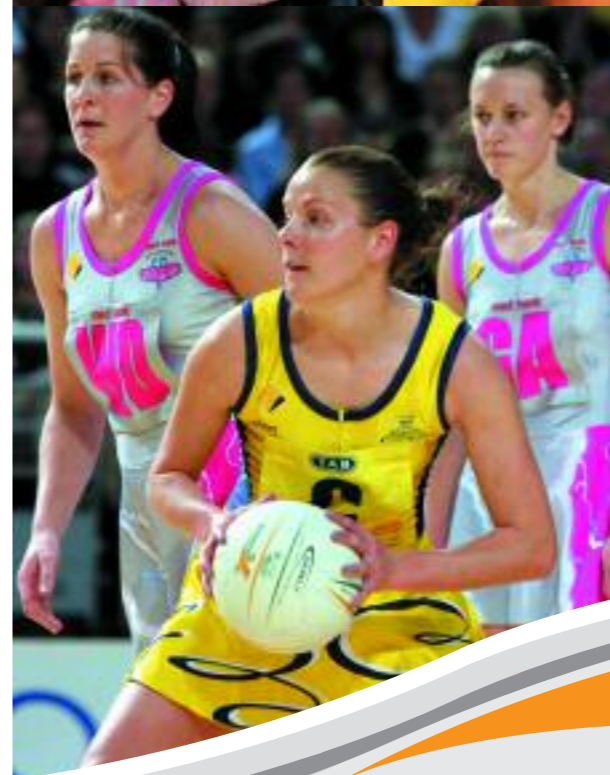
A full review of the Commonwealth Bank Trophy was conducted in early 2005 with many of the recommendations implemented. Further modifications will be made to the competition in 2006.

For the first time the Final Series was run in close cooperation with the Host Member Organisations to ensure the best event possible was showcased for the Commonwealth Bank Trophy.

Operational management of all domestic Test Matches during 2005 was managed efficiently. The 2005 Holden Test Series against South Africa, England and New Zealand was a great success, though attendances for matches against South Africa and England were below expectations. The match against New Zealand in June attracted in excess of 12,000 spectators at the Sydney SuperDome.

# Commonwealth Bank Trophy



2005 was another strong year for the world's most prestigious domestic netball competition the Commonwealth Bank Trophy. The ninth year of the national competition has again delivered a healthy increase in crowd attendances with more than 130,000 spectators experiencing the best of Australia's netball action.

Netball Australia continued to take the game to our members in 2005 with Commonwealth Bank Trophy games played in the regional centres of Geelong, Wollongong, Townsville and Eaton and also returned to Darwin following last year's successful fixture there. These games proved hugely successful and provided a tangible boost in the sports exposure and awareness in regional Australia and an expanded schedule is again planned for 2006.

The Grand Final between the Melbourne Phoenix and the Sydney TAB Swifts was a replay of last year's tightly fought contest but in 2005 it was the Melbourne Phoenix who took inspiration from the parochial home crowd beating the Sydney TAB Swifts 61 to 44 at Vodafone Arena.

Netball Australia thanks the Commonwealth Bank of Australia for its continued support and investment in netball from grass roots to the elite level. The partnership between Netball Australia and the Commonwealth Bank of Australia has already constituted a powerful presence in the Australian business and social community and we look forward to building this partnership to further enhance and develop our sport.

Through the continuation of this mutually strong and beneficial relationship the Commonwealth Bank of Australia aligns itself with a positive and clean sport property that enhances its community profile and reputation and contributes significantly to the affirmation of women athletes as role models in the wider community.

Netball's loyal broadcast partner, the ABC, continues to show its support and investment in the sport through its enhanced and innovative technical coverage of netball throughout Australia.

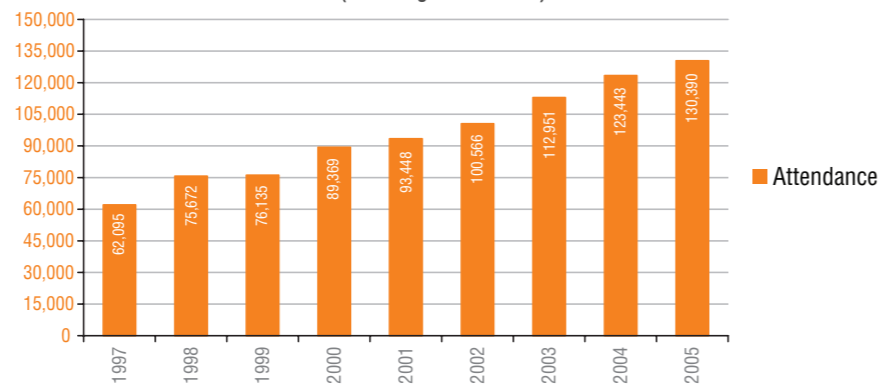

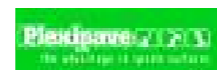

# Auditors Report

## INDEPENDENT AUDITORS' REPORT TO THE MEMBERS OF ALL AUSTRALIA NETBALL ASSOCIATION LIMITED

### Scope

The financial report comprises the income statements, balance sheets, statements of changes in equity, cash flow statements, accompanying notes to the financial statements (notes 1 to 20), and the directors' declaration, (set out on pages 10 to 22), for All Australia Netball Association Limited (the "company"), for the year ended 31 December 2005.

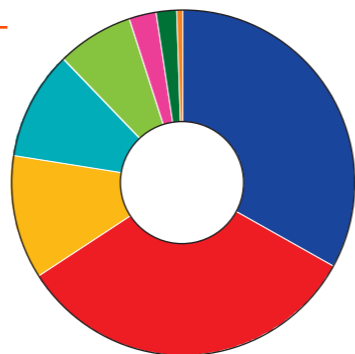

Membership Analysis by State shows the breakdown of registered members by State and Territory in 2005.

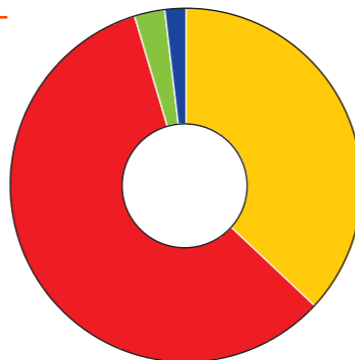

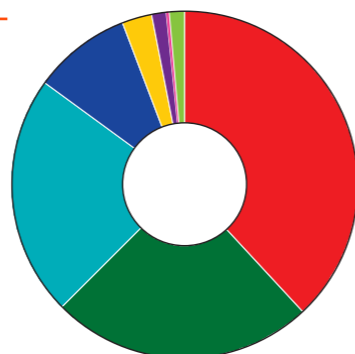

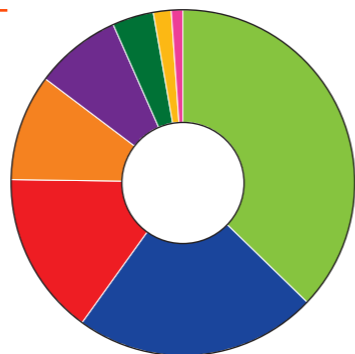
